Known Bugs and Issues

- ✓ The Website(s) field under Customer info is not being synced between Acumatica and Adobe. (CPC-277)
- Acumatica is not displaying the Column Section name in the Merchandising section for Stock and Non-Stock items. (CPC-305)
- ✓ The Merchandise section remains visible on the Stock Items page even after the Dynamic Merchandising checkbox is unselected and saved on the CommercePro Features Management page. (CPC-306)
- ✓ The user is not able to delete S3 Images for Stock, Non-Stock, and Template Items that were added manually. (CPC-309)
- ✓ When Create Kit On Fly is disabled, the Quick Kits Assembly Management grid is not disabled on the Sales Order Preferences page. (CPC-312)
- ✓ Duplicate customers are not synced from Adobe to Acumatica even after the Ignore email checkbox is selected. (CPC-323)
- ✓ Template items are shown under Free Items in the Related Items tab of the Stock Items page in Acumatica. (CPC-331)
- √ When Validate Contacts and Active check boxes are enabled and saved, Ignore Email is also enabled.
 (CPC-349)
- ✓ When the Kit Qty is updated for Matrix items and processed, the Kit Qty is not being updated for Stock/Non-Stock items at the item level. (CPC-357)
- ✓ Duplicate customers are not synced from Adobe to Acumatica even when Tentant Base is selected for Customer Email Uniqueness on the Accounts Receivable Preferences page and the Ignore Email checkbox is enabled. (CPC-371)
- ✓ Duplicate records are not synced from Adobe to Acumatica even when the Ignore Email and Ignore Email and Ignore Duplicates checkboxes are enabled on the Accounts Receivable Preferences page. (CPC-372)
- ✓ Acumatica is displaying Refresh Kit Price Process, Process Quick Kits, and Clear Log, which are Commerce pro-related options, without a license being applied. (CPC-329)
- ✓ The user is facing an error when a vendor is selected in the Vendor Inventory screen after the Vendor ID is added in the Vendors tab on the item level page of Stock Items. (CPC-334)
- ✓ When an order is processed with Stock Items, the vendor quantity is not being updated as per ACM Vendor Inventory Details By Date. (CPC-336)
- ✓ The User is facing an error when trying to save the preferences after selecting Order Types under Order Uniqueness in the Sales Order Preferences screen. (CPC-338)



- ✓ After Numbering Settings and Target Items are updated on the Inventory Preferences page and a new rule is created on the Category Rules page, when a new Stock Item is created that satisfies the created rule, the Category ID under Sales Categories is not being updated. (CPC-342)
- ✓ On the order level page of a Sales Order, when Line Item Enhancement is clicked and the Inventory ID search icon is selected in the Add Enhancement pop-up, the application shows all stock items instead of only the associated items. (CPC-346)
- ✓ The User is facing an error when they are trying to save the preferences after selecting Create Kit Assembly on Sales Order Save or Create Kit Assembly on Shipment Creation under Quick Kits Assembly Management in the Sales Order Preferences screen. (CPC-347)
- ✓ The User is facing an error when adding new Applicable Item Classes and Applicable Inventory Items. (CPC-348)
- ✓ The Create Kit Assembly option is still visible on the order level page of Sales Orders after the Create Kit on Fly is unselected on the CommercePro Features Management page. (CPC-361)
- ✓ On the Calculate Kit Qty Process screen in Acumatica, after clicking Process, the Processing window is showing Errors, and the user is unable to complete the Process action. (CPC-344)
- ✓ The Kit Qty Last Calculated details are not being updated in real time on the Inventory Preferences page of Acumatica. (CPC-358)
- ✓ Once the Inventory Updated Date is passed, the Days to Keep Inventory, Quantity At the Vendor, and Available For Sale (%) are still reflected with pre-set values without becoming 0. (CPC-335)
- ✓ After the Sales Unit and Conversion Factor are updated in the General tab of a Template item page, the UOM Price in the Price/Cost tab is not being updated based on the Default Price. (CPC-341)
- ✓ Users are unable to view the Merchandising Section on the Item Classes page even after the feature is enabled on the CommercePro Features Management page. (CPC-343)
- ✓ A shipping restriction validation message is not displayed on the Sales Order page when the address selected is in the state that is added to Shipping Restriction Zones. (CPC-356)
- ✓ When the Create Kit Assembly on Sales Order Save checkbox under Quick Kits Assembly Management in the Order Types page is selected, the Allocated checkbox is not selected in the Line Details page at the order level of a Sales Order. (CPC-359)
- ✓ When the Create Kit Assembly on Shipment Creation option is selected at the Order Type level, the corresponding sales order record is visible on the Process Quick Kits screen. (CPC-360)
- ✓ When the Customer Order Summary feature is enabled on the CommercePro Features Management page, Acumatica is taking a long time when a Sales Order is being saved. (CPC-318)
- ✓ The Possible Kit Qty Calculation on the Stock Items page is not being calculated based on the UOM selected in the Kit Specifications. (CPC-398)

CPC-306	Dynamic Merchandising: When the Dynamic merchandise feature is disabled then Merchandise tab is still displayed for the stock item
CPC-309	S3 Image: Unable to delete the manually added image for Stock ,Non stock and Template Items
CPC-312	When the Create Kit on Fly is disabled in Commerce Pro feature Management then the Quick Kits Assembly Management option should not be available in Sales Order Preferences screen
CPC-323	Ignore email uniqueness is not working for Customer class Base for duplicate Customers synced from Magento
CPC-331	User able to view the Template item Inventory ID details on the Stock items screen
CPC-349	When the Validate contacts and Active checkboxes are selected for the Branch based then email uniqueness validation is getting displayed for all the Unique email address
CPC-357	Kit Qty details are not getting updated at Stock item level
CPC-371	Tenant Based : When the Ignore email is selected for the Tenant based when the duplicate customers are synced from Magento then duplicate records are not created in Acumatica
CPC-372	Customer Class Based : Ignore email and Ignore Duplicates functionality is not working for the duplicate customers synced from Magento
CPC-329	User can view the CP screens without applying the CP license.
CPC-334	User is encountering an error message on the Vendor Inventory screen when selecting the Vendor ID.
CPC-336	Vendor Inventory Quantity is not decreasing at the ACM Vendor screen, when an order is placed with a Stock item
CPC-338	When the Order types are selected for duplicate order check then facing issue
CPC-342	Auto Assign Sales Categories: Category ID is not updated for the Non Stock Items
CPC-346	When the Kit item is added in the SO then in the Line item enhancement pop up in the Kit component all the stock items are displayed instead of the associated items
CPC-347	Creating Kits on the Fly: Unable to select the options Create Kit Assembly on SO save and Create Kit Assembly on Shipment Confirmation on the Sales order preferences screen
CPC-348	Blocker-User is unable to select the Item class and Inventory Item in the shipping restriction tab
CPC-361	Create Kit Assembly checkbox is displayed in SO Screen even though Create Kit assembly checkbox is unchecked in configurations



CPC-344	Kit Qty Display: User unable to view the updated Qty on the Stock item screen when user creates a receipt and performs process action on Calculate Kit Qty Process
CPC-358	Kit Qty last calculated date is not updated in Inventory preferences screen
CPC-335	Users shouldn't be able to view the Vendor Quantity on the ACM Vendor screen, and the Vendor details should show as zero on the Stock Item screen when the Days to keep inventory date expires
CPC-341	UOM Price is not getting updated for the Template Items
CPC-343	Blocker: Unable to view the Merchandize tab even though feature is enabled
CPC-356	Shipping restriction validation messages are not displayed for sales order if the state is selected in the shipping restriction zone
CPC-359	The Allocated checkbox is not selected at Order level once the Kit is assembled based on the Order type quick kits settings
CPC-360	Sales order record is displayed in the Process quick kits screen when the "Create Kit Assembly on Shipment Creation" option is selected at Order type
CPC-318	Multiple users or background process attempt to perform same operation records simultaneously 24R1
CPC-398	Kit Possible Qty Calculation is not respecting the UOM selected on the Kit Specifications screen.
