New Features and Enhancements

Known Bugs and Issues

- ✓ After selecting the Enable for Magento Sync checkbox on the Item Classes page, the application displays an error when the user clicks Save without applying the Commerce Pro license. (CPC-83)
- ✓ Clicking the Refresh S3 Images option in the S3 Images tab of a Stock/Non-Stock Item is causing the S3 Images tab to disappear. (CPC-220)
- ✓ When images are uploaded for a child item from the S3 images portal, the uploaded images are also reflected under the parent item. (CPC-225)
- ✓ Processed S3 images are not appearing under the S3 Images tab on the Stock Items page for matrix items. (CPC-239)
- ✓ The user is facing a failure error when performing the Create Shipment action from the Process Orders screen. (CPC-87)
- ✓ When navigating to the Customer Classes page under Preferences from the Receivables menu and selecting the Class ID as INTERCO, if the customer classes are updated with Website(s) under Commerce Pro Multi-Branch Support set to blank, the previously entered websites still appear. (CPC-213)
- ✓ The user is able to see the Commerce Pro Multi-Branch Support option even after unselecting the Multi-Website Support for Customers and Products checkbox on the CommercePro Features Management page. (CPC-214)
- ✓ The application is not showing a validation message on the Sales Orders screen when different website(s) are selected on the Customers and Stock Items pages. (CPC-215)
- ✓ After the Vendor Inventory Management checkbox is unselected in the CommercePro Features Management page, when user navigates to the Update Vendor Inventory, ACM Vendor Inventory Details By Date, or Vendor Inventory pages, a message to redirect to the CommercePro Features Management screen and Hyperlink are not displayed and the Vendor Inventory Management checkbox is enable automatically. (CPC-216)



- ✓ After publishing the latest package in Acumatica, the user is not able to view the Sales Price and Vendor Price grids in the Price/Cost tab of the Stock Items page. (CPC-219)
- ✓ The application is not showing a shipping restriction alert when a shipment is created if multiple locations are added under Shipping Restriction Zones. (CPC-223)
- ✓ On the Item Classes page, the user is facing an error when the Row Position value and Column Position value are set to the same, even if the Section Sort Order is different. (CPC-247)
- ✓ The Merchandise section remains visible on the Non-Stock Items page even after the Dynamic Merchandising checkbox is unselected and saved on the CommercePro Features Management page. (CPC-248)
- ✓ The stock items with an unassigned location are not being included during the Inventory Sync between Adobe and Acumatica. (CPC-92)
- ✓ The user is able to view the Vendor Qty of the Stock Items on the ACM Vendor Inventory Details By Date page even if a warehouse is not mapped in the Brach Wise Inventory Association. (CPC-217)
- ✓ The application is showing an error message on the Processing pop-up screen on the Process Quick Kits page. (CPC-222)

All identified bugs and issues have been analyzed and rectified.

CPC-220	S3 Images- When user performs Refresh S3 Images button on Stock Item & Nonstock item screen the S3 images tabs are getting vanished
CPC-225	S3 Images-When users add images to child items, they automatically sync to the parent item.
CPC-239	User is not able to view the S3 Images on the Template Items screen when user perform Process action on S3 Images Processing screen
CPC-87	Facing issue with Process Order while creating Shipment
CPC-213	User is not able to view the websites as null when user assign the empty websites for Customer class on Customer screen
CPC-214	QA Bug - Multi Websites- User is not able to view the Websites field on the Customer, Customer Class screen when a user disables the websites Checkbox on CP features screen
CPC-215	QA Bug - Multi Websites- User is not able to view the validation message on Sales Order screen when suer different websites for Customer and Stock item



CPC-216	QA Bug - Vendor Inventory- The Vendor Inventory Management Checkbox will be automatically enabled on the CP feature management screen after it has been disabled.
CPC-217	QA Bug - Vendor Inventory- Users is not able to view the Vendor Quantity on the ACM vendor screen if the product is not assigned with Branches/Warehouse.
CPC-219	QA Bug - Verify user can able to view the below column names on the Sales Price grid
CPC-222	Explanation needed
CPC-223	Shipping restriction alert is not displayed for the Order if multiple states are selected and if only one State PIN code is given
CPC-247	Dynamic Merchandising: While providing the Section Sort order for multiple attributes getting the error message as "The Combination of Row and Column Position should be unique"
CPC-248	Dynamic Merchandising: User able to view the Merchandise section in Non-Stock Items screen even if the feature is disabled in CP Feature Management
CPC-92	With Old Logic in Allparts Unassigned location is not considering on Inventory sync which impacting Kit Qty
